### 2. COMPOSITION/INFORMATION ON INGREDIENTS

<b>Preparation description</b>	: Synthetic hydrocarbon oil grease thickened with clay, containing additives.
<b>Additional Information</b>	: Synthetic hydrocarbon oil grease thickened with clay, containing additives.

### 3. HAZARDS IDENTIFICATION

<b>EC Classification</b>	: Not classified as dangerous under EC criteria.
<b>Health Hazards</b>	: Not expected to be a health hazard when used under normal conditions. Prolonged or repeated skin contact without proper cleaning can clog the pores of the skin resulting in disorders such as oil acne/folliculitis. High-pressure injection under the skin may cause serious damage including local necrosis. Used grease may contain harmful impurities.
<b>Signs and Symptoms</b>	: Local necrosis is evidenced by delayed onset of pain and tissue damage a few hours following injection. Oil acne/folliculitis signs and symptoms may include formation of black pustules and spots on the skin of exposed areas. Ingestion may result in nausea, vomiting and/or diarrhoea.
<b>Safety Hazards</b>	: Not classified as flammable but will burn.
<b>Environmental Hazards</b>	: Not classified as dangerous for the environment.

### 4. FIRST AID MEASURES

<b>General Information</b>	: Not expected to be a health hazard when used under normal conditions.
<b>Inhalation</b>	: No treatment necessary under normal conditions of use. If symptoms persist, obtain medical advice.
<b>Skin Contact</b>	: Remove contaminated clothing. Flush exposed area with water and follow by washing with soap if available. When using high

pressure equipment, injection of product under the skin can occur. If high pressure injuries occur, the casualty should be sent immediately to a hospital. Do not wait for symptoms to develop. If persistent irritation occurs, obtain medical attention. Obtain medical attention even in the absence of apparent wounds.

- Eye Contact** : Flush eye with copious quantities of water. If persistent irritation occurs, obtain medical attention.
- Ingestion** : In general no treatment is necessary unless large quantities are swallowed, however, get medical advice.
- Advice to Physician** : Treat symptomatically. High pressure injection injuries require prompt surgical intervention and possibly steroid therapy, to minimise tissue damage and loss of function. Because entry wounds are small and do not reflect the seriousness of the underlying damage, surgical exploration to determine the extent of involvement may be necessary. Local anaesthetics or hot soaks should be avoided because they can contribute to swelling, vasospasm and ischaemia. Prompt surgical decompression, debridement and evacuation of foreign material should be performed under general anaesthetics, and wide exploration is essential.

### 5. FIRE FIGHTING MEASURES

Clear fire area of all non-emergency personnel.

- Specific Hazards** : Hazardous combustion products may include: A complex mixture of airborne solid and liquid particulates and gases (smoke). Carbon monoxide. Unidentified organic and inorganic compounds.

<b>Storage</b>	: Keep container tightly closed and in a cool, well-ventilated place. Use properly labelled and closeable containers. Storage Temperature: -50 - 50 °C / -58 - 122 °F

<b>Unsuitable Materials</b>	: PVC.
<b>Additional Information</b>	: Polyethylene containers should not be exposed to high temperatures because of possible risk of distortion.

<b>Additional Information</b>	: Due to the product's semi-solid consistency, generation of mists and dusts is unlikely to occur.
<b>Exposure Controls</b>	: The level of protection and types of controls necessary will vary depending upon potential exposure conditions. Select controls based on a risk assessment of local circumstances. Appropriate measures include: Adequate ventilation to control airborne concentrations. Where material is heated, sprayed or mist formed, there is greater potential for airborne concentrations to be generated.
<b>Personal Protective Equipment</b>	: Personal protective equipment (PPE) should meet recommended national standards. Check with PPE suppliers.
<b>Respiratory Protection</b>	: No respiratory protection is ordinarily required under normal conditions of use. In accordance with good industrial hygiene practices, precautions should be taken to avoid breathing of material. <b>Eye Protection</b>	: Wear safety glasses or full face shield if splashes are likely to occur.

### 12. ECOLOGICAL INFORMATION

Ecotoxicological data have not been determined specifically for this product. Information given is based on a knowledge of the components and the ecotoxicology of similar products.

<b>Acute Toxicity</b>	: Poorly soluble mixture. May cause physical fouling of aquatic organisms. Expected to be practically non toxic: LL/EL/IL50 > 100 mg/l (to aquatic organisms) (LL/EL50 expressed as the nominal amount of product required to prepare aqueous test extract).
<b>Mobility</b>	: Semi-solid under most environmental conditions. Floats on water. If it enters soil, it will adsorb to soil particles and will not be mobile.
<b>Persistence/degradability</b>	: Expected to be not readily biodegradable. Major constituents are expected to be inherently biodegradable, but the product contains components that may persist in the environment.
