2. COMPOSITION/INFORMATION ON INGREDIENTS

Preparation Description : A lubricating grease containing highly-refined mineral oils and

additives.

Additional Information : The highly refined mineral oil contains <3% (w/w) DMSO-

3. HAZARDS IDENTIFICATION
